Below are answers to written questions received by the Agency for **RFA 034-25/26**, RHTP Specialty and Acute Care Bundle (Bundle Two).

Vendor Name	Question	Answer
QHS Labs	Can the program office identify eligible rural health organizations, FQHCs, regional behavioral health networks, or rural collaboratives seeking a technology partner and may benefit from QHSLab's existing infrastructure for a competitive RFA 034, 035, or 038 application?	The Agency cannot identify partner organizations for applicants.

Item 2

Below are answers to general, written questions received by the Agency for the Rural Health Transformation Program (RHTP) deemed by the Agency to pertain to all RFAs released for this Program.

Vendor Name	Question	Answer
Bond Community Health Center, Inc.	Can the funds be used to pay the salaries of medical providers and medical support staff?	RHTP funds cannot be used to pay clinician salaries for direct patient care services. This restriction applies regardless of the patient's insurance status or payer source.
Bond Community Health Center, Inc.	Can the funds be used to disarticulate, move, and reassemble a modular building to use as a permanent clinic?	Applicants must submit a detailed renovation plan and cost estimate with the application. Renovation costs may not exceed 20% of the total funding in a given budget period and must be clearly linked to program goals. Major construction is not allowed under the RHTP grant.
Bond Community Health Center, Inc.	Can the funds be used to lease land?	No.
Bond Community Health Center, Inc.	Can a lead organization serve as the lead for multiple applications?	Yes, as long as the lead applicant can show capacity to serve in this role for each application submitted.
Bond Community Health Center, Inc.	Can a lead organization lead more than one collaborative group (Bundle), within the same region, if they are looking to serve different counties?	See Addendum No. 3, Item 2 - General RHTP Questions and Answers, answer to Question #92.
Purity Health	For context: Purity Health is a healthcare technology and clinical-research organization currently in partnership discussions with a prospective Florida-authorized lead applicant. We anticipate participating as a formal subcontractor providing a clinical-workflow and protocol-encoding technology layer under that lead applicant's RFA 036 application. The	The Agency does not make determinations regarding organizational or entity structure prior to the receipt of applications. Question 1 — § 3.1 Category Selection The prospective lead applicant operates multiple Florida clinic sites delivering women's-health primary care, OB/GYN, and behavioral health services. Clinical leadership at the Florida sites combines MD medical directors with certified nurse-midwives and women's-health nurse practitioners delivering primary obstetric and gynecologic care. Under § 3.1, would the Agency consider this entity profile better suited to filing as a "physician group and multi-specialty medical practice" or as a "nurse practitioner- or physician assistant-led primary care practice"? Are there specific elements of Section C — Organizational Capacity and Eligibility documentation that the Agency would expect to see to distinguish a successful Stage 1 review under each category?	proposed program. Purity Health	§ 3.2 Min Qual #4 Five-Year Continuous-Operation Test Where the Florida Filing Entity Is a Subsidiary The prospective lead applicant is structured as a Florida-authorized legal entity that is a subsidiary of a parent organization headquartered outside Florida. The parent organization has more than five years of continuous operation delivering primary care and women's-health services across multiple states. The Florida subsidiary itself was registered with the Florida Department of State in 2025 and may have less than five years of standalone Florida operating history as of the June 10, 2026 application deadline. May the application reference the parent organization's enterprise-level operational history to satisfy § 3.2 Minimum Qualification #4, with the Florida subsidiary serving as the filing entity for purposes of Minimum Qualification #1 (Florida authorization)? If so, what documentation linking the parent organization's history to the Florida filing entity will the Agency expect to see in Section C — Organizational Capacity and Eligibility? We appreciate the Agency's guidance on these points in advance of the application deadline. Please let me know if any further clarification on the entity profile or the partnership structure would help the Agency provide a complete response.
