The Vendor {Bidder} must document that it can meet the technical requirements of this Bid Solicitation. Each response in the proposal to a mandatory item in the Bid Solicitation Section 4.0 Scope of Work must contain clear language that states full compliance.

1. Bid Solicitation Section 4.2 Tower Relamping and Tower Top Amplifier Replacements
How will the Vendor {Bidder} be compliant with Section 4.2 Tower Relamping and Tower Top Amplifier Replacements?

2. Bid Solicitation Section 4.3 Tower Inspections
 - a) How will the Vendor {Bidder} be compliant with Section 4.3 Tower Inspections? Specifically discuss how the Vendor {Bidder} will evaluate and document items A through H in Section 4.3.

- b) How will the Vendor {Bidder} manage the inspection schedule? The Vendor {Bidder} should attach a sample report detailing deficiencies and costs for performance restoration.

3. Bid Solicitation Section 4.4 Antenna Replacement and Performance Capability
Discuss how the Vendor's {Bidder's} approach to performing Items A through M under "Antenna Replacement and Performance Capability."

4. Bid Solicitation Section 4.6.2 Time and Material (T&M) Support: Material Costs
 The Vendor {Bidder} must identify the materials and equipment manufacturer(s) and associated catalog (s) it will use to purchase materials and equipment and the amount of discount it will provide the State from the catalog’s list prices.

5. Bid Solicitation Section 4.7 Response Time and Coverage
 How will the Vendor {Bidder} comply with the Response Time and Coverage requirements?

6. Bid Solicitation Section 4.8 Lighting Protection and Grounding
 a) How will the Vendor {Bidder} comply with the requirements for Lighting Protection and Grounding?

b) Standards and Codes: Vendor {Bidder} must disclose any citations given by OSHA for the past five years. Vendor {Bidder} must provide copies of its OSHA logs for the past two years and attach the logs to this Questionnaire.

7. Bid Solicitation Section 4.9.3 Equipment/Staffing Availability

a) Response to subsection A Equipment. The Vendor {Bidder} must provide a list of all equipment that will be used during the Master P.O. {Contract}. Vendor's {Bidder's} equipment list must include vehicles, hoists, cables, antennas, and miscellaneous repair parts. The Vendor {Bidder} shall further describe the heavy equipment in its inventory and state whether this equipment can perform the requirements listed in Sections 4.2, 4.3 and 4.4. The Vendor {Bidder} must identify the location(s) where its equipment is stored so response time can be evaluated. The Vendor's {Bidder's} location(s) may be subject to inspection prior to award.

- d) The Vendor {Bidder} must describe its experience and acknowledge its ability to perform the duties listed in subsections “a” through “g”.
