



Notice of Solicitation

The Region 4 Education Service Center (ESC), in cooperation with the OMNIA Partners Public Sector cooperative purchasing organization, has released a Request for Proposals (RFP) for the purchase of Modular Buildings, Portable Storage & Restrooms, and Relocatable Products. The Chief Procurement Officer for General Services (CPO-GS) has authorized that the State of Illinois and/or its governmental units may participate in the resulting contract(s) on a non-mandatory basis. This opportunity is being published in the Illinois Procurement Bulletin to only give notice to interested vendors; you must obtain the solicitation from the OMNIA Partners site portal's publication in the OMNIA Partners procurement system website. Please see the link below.

The purpose of this RFP is to establish Master Agreements with qualified Offerors to provide services related to Modular Buildings, Portable Storage & Restrooms, and Relocatable Products for all Participating Entities. The objective of this RFP is to obtain best value and achieve more favorable pricing than is obtainable by an individual state or local government entity because of the collective volume of potential purchases by numerous state and local government entities. The Master Agreement(s) resulting from this procurement shall be extended to state governments (including departments, agencies, institutions), institutions of higher education, political subdivisions (i.e., school districts, counties, cities, etc., the District of Columbia, territories of the United States, and other eligible entities subject to approval of the individual state procurement director and compliance with applicable statutory and regulatory provisions.

The initial term of the Master Agreement shall be three (3) years, unless terminated, canceled, or extended as otherwise provided herein. Region 4 ESC shall have the right in its sole discretion to renew the Contract for additional terms up to two (2) years after the end of the initial term or for a lesser period of time as determined by Region 4 ESC by providing written notice to the Contractor of Region 4 ESC's intent to renew thirty (30) days prior to the expiration of the original term. Contractor acknowledges and understands Region 4 ESC is under no obligation whatsoever to extend the term of this Contract. In the event the proposal term, including renewals, ends before another proposal is executed, proposal prices and discounts may be extended on a month-to-month basis by mutual consent. Extensions are limited to the lesser of: a) six (6) additional monthly terms, or b) the time which is required to complete a new solicitation for the goods and services provided for in this solicitation. Notwithstanding the foregoing paragraph, the term of the Contract, including any extension of the original term, shall be further extended until the expiration of any Purchase Order issued within the Contract term for a period of up to one year beyond the Contract term.

The resulting Master Agreement contract(s) will provide Participating Entities with access to Golf Utility and Hospitality Carts Parts Accessories Supplies and Related Services. Please do not contact the State of Illinois with questions about this solicitation.
