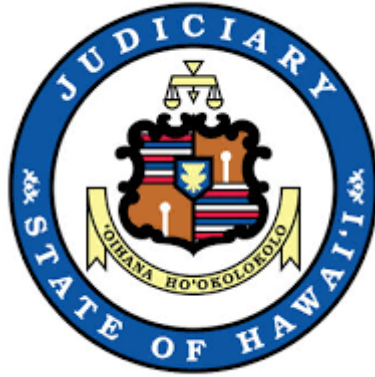

ADDENDUM NO. 1

DATE ISSUED: June 23, 2026

1. Revise RFP J27084, Section 6.20.2, in its entirety to read as follows:

6.20.2 The contract may be extended upon mutual agreement of the parties. For any extension period, the contract hourly rates shall remain the same as those in effect during the preceding contract year, unless adjusted in accordance with the Price Adjustment provision or otherwise negotiated and mutually agreed upon by the parties.

Any increase in the contract hourly rates for an extension period shall not exceed five percent (5%) of the rates in effect during the preceding contract year. Requests for increases exceeding five percent (5%) must be fully justified and are subject to the Judiciary's review and approval. The Contractor shall provide supporting documentation substantiating the requested rate increase exceeding five percent (5%).

Refer to the Price Adjustment sections of these Special Provisions for additional requirements and procedures.

2. Revise RFP J27084, Section 4.3.3, Wage Certificate, fourth Paragraph to read as follows:

The basic hourly wages paid to similar State positions starting July 1, 2026 is expected to be:

Armed Security Guard/Armed Security Guard Supervisor

It is the Offeror's responsibility to verify the accuracy of the wage rates contained herein, updates and to provide for changes in the minimum wages, which must be paid to personnel.

3. Revise the Pricing Sheet – Security Guard Services in its entirety with the attached Pricing Sheet – Security Guard Services dated 06/23/2026.
